Otteri Nullah is a naturally formed canal which runs for a distance of 10.5 kms in in east – west direction, starting from Annanagar to Buckingham canal. Earlier this was used for irrigation purpose and after development of the city, it served as a channel to carry rain water along its course during monsoon and during non monsoon period it used to be dry. Its maximum width is only 9 meters with a limited water carrying capacity.

However lately an open diversion channel has been constructed and connected to the Otteri Nullah, which carries surplus flood water from 4 lakes, namely Ayapakkam, Ambattur, Kolathur & Villivakkam to Otteri Nullah during monsoon days and the same channel is carrying the industrial effluents with toxic fumes throughout the year causing severe health hazards to lakhs of people residing along the Otteri Nullah. On top of it sewage & stormwater drains from Villivakkam and colonies around Nadhamuni area have been diverted into Otteri Nullah

We the Federation of Annanagar residents associations (FOARA) with more than 20,000 voters would like to make the following proposals to prevent flooding in our locality and to stop the diversion of Industrial effluents in to Otteri Nullah.

- 1. Revive the Cut & Close Diversion channel in Park Road(From Wheels India gate to Cooum)**
- 2. Construct Cut & Close Diversion channel in New Avadi Road(From Padi Flyover to the already existing 3rd Avenue diversion channel to Cooum)**
- 3. Close the Korattur canal joining Otteri Nullah near Thendral Colony.**
- 4. Desilt 3rd Avenue Diversion channel & increase manholes for cleaning**
- 5. Remove encroachments on Otteri Nullah**
- 6. Construct tall retaining walls along Otteri Nullah**
- 7. Increase the width and height of the bridges across Otteri Nullah in (a) 3rd Avenue and (b) ICF South Colony**
- 8. Desilt all the existing SWD in Annanagar**
- 9. Construct atleast 1 SWD in all 30Ft roads,**
- 10. Construct 2 SWD in all Main Roads of Annanagar**
